## A BILL FOR AN ACT

RELATING TO PESTICIDES.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that providing a safe and
- 2 lawful way to dispose of banned, outdated, or unwanted
- 3 pesticides is critical to the State's environmental management
- 4 efforts. While Hawaii prohibits the disposal of agricultural
- 5 pesticides in sanitary landfills, no safe or legal alternatives
- 6 for their disposal are currently offered.
- 7 The legislature recognizes that more than forty states have
- 8 successfully created low-cost pesticide disposal collection
- 9 programs to ensure that unwanted agricultural pesticides are
- 10 safely discarded.
- 11 Accordingly, the purpose of this Act is to require the
- 12 department of agriculture, in consultation with the department
- 13 of health, to develop and implement a one-time, low-cost
- 14 pesticide disposal collection program.
- 15 SECTION 2. (a) The department of agriculture, in
- 16 consultation with the department of health, shall develop and
- 17 implement a pesticide disposal collection program to provide a



- 1 one-time, affordable, and accessible means for bona fide
- 2 agricultural entities and those that have inherited restricted
- 3 use and nonrestricted use pesticides to dispose of pesticides
- 4 through a pesticide disposal collection program.
- 5 (b) The department of agriculture shall establish on the
- 6 islands of Hawaii, Kauai, Lanai, Maui, Molokai, and Oahu
- 7 disposal locations for restricted use and nonrestricted use
- 8 pesticides to effectuate the purposes of this Act. Each
- 9 disposal location shall offer the opportunity for bona fide
- 10 agricultural entities to dispose of restricted use and
- 11 nonrestricted use pesticides for thirty days.
- 12 (c) The department of agriculture shall operate the
- 13 pesticide disposal collection program as a free program to
- 14 encourage the safe and legal disposal of restricted use and
- 15 nonrestricted use pesticides; provided that the department of
- 16 agriculture shall not charge a fee for the disposal, up to a
- 17 maximum weight of fifty pounds, of restricted use pesticides or
- 18 nonrestricted use pesticides.
- 19 (d) The department of agriculture shall implement the
- 20 pesticide disposal collection program no later than June 30,

- 1 2023, and operate the program for a duration to be determined by
- 2 the department of agriculture.
- 3 (e) For purposes of this part, "bona fide agricultural
- 4 entity" means one or more individuals or a company, corporation,
- 5 partnership, association, or other legal entity in the State
- 6 that engages in or has engaged in an agricultural operation as
- 7 defined in section 46-88(d), Hawaii Revised Statutes, provided
- 8 that a bona fide agricultural entity shall include any
- 9 successor, heir, or beneficiary that received from a bona fide
- 10 agricultural entity any restricted use or nonrestricted use
- 11 pesticide.
- 12 SECTION 3. There is appropriated out of the general
- 13 revenues of the State of Hawaii the sum of \$800,000 or so much
- 14 thereof as may be necessary for fiscal year 2022-2023 for
- 15 establishing and operating the pesticide disposal collection
- 16 program.
- 17 The sum appropriated shall be expended by the department of
- 18 agriculture for the purposes of this Act.
- 19 SECTION 4. This Act shall take effect on July 1, 2022.

## Report Title:

Pesticide Disposal Program; Steering Committee; Appropriation

## Description:

Requires the Department of Agriculture, in consultation with the Department of Health, to develop and implement a one-time pesticide disposal collection program, for a duration to be determined by the department. Requires the Department of Agriculture to convene a steering committee to guide and monitor the pesticide disposal collection program. Makes an appropriation. (SD1)
