### A BILL FOR AN ACT

PROPOSING AN AMENDMENT TO ARTICLE I OF THE HAWAII STATE
CONSTITUTION TO PROHIBIT ANY ENCUMBRANCE ON THE RIGHT TO
OWN, POSSESS, AND USE ANY MEDIUM OF EXCHANGE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to propose an
- 2 amendment to article I of the Constitution of the State of
- 3 Hawaii by adding a new section to prohibit any encumbrance on
- 4 the right to own, possess, and use any medium of exchange.
- 5 Specifically, this Act:
- 6 (1) Identifies the right of individuals to own, possess,
- 7 and use any medium of exchange; and
- 8 (2) Prohibits any encumbrance on an individual's right to
- 9 own, possess, and use any medium of exchange; provided
- 10 that this prohibition does not restrict the State from
- 11 determining the mediums of exchange required for its
- operations.
- 13 SECTION 2. Article I of the Constitution of the State of
- 14 Hawaii is amended by adding a new section to read as follows:
- 15 "Section . No law shall be enacted prohibiting or
- 16 abridging the freedom to own, possess, and use a mutually agreed

2	currency, or scrip, when trading and contracting for goods and
3	services. The right to own, possess, and use a mutually agreed
4	upon medium of exchange when trading and contracting for goods
5	and services shall not be construed to restrict the State of
6	Hawaii from determining the mediums of exchange required for it:

8	SECTION 3. The question to be printed on the ballot shall
9	be as follows:
10	"Shall the legislature be prohibited from enacting any
11	encumbrances on the right to own, possess, and use a
12	mutually agreed upon medium of exchange when trading and
13	contracting for goods and services; provided that the
14	government of the State of Hawaii may continue to determine
15	the mediums of exchange that it requires for its
16	operations?"
17	SECTION 4. New constitutional material is underscored.
