A BILL FOR AN ACT

RELATING TO ELECTRIC GUNS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that it is imperative to
- 2 protect the health and safety of the public by regulating where
- 3 electric guns may be carried. Certain sensitive locations where
- 4 electric guns should be regulated include schools, government
- 5 buildings, and places where open meetings take place. Many
- 6 states and federal agencies have enacted similar legislation and
- 7 regulations to place location restrictions on electric guns.
- 8 The legislature further finds that to address the effect of
- 9 a court ruling on the ban of electric guns in Hawaii, Act 183,
- 10 Sessions Laws of Hawaii 2021 (Act 183), repealed the prohibition
- 11 on electric guns while ensuring public safety. Act 183 provided
- 12 for regulations and rules on the use, storage, transfer,
- 13 disposal, and purchase of electric guns and electric projectile
- 14 guns. Location restrictions are additionally necessary to
- 15 protect public health and safety.

1	The purpose of this Act is to prohibit individuals from		
2	carrying an electric gun in or near certain sensitive locations,		
3	with exceptions.		
4	SECTION 2. Chapter 134, Hawaii Revised Statutes, is		
5	amended by adding a new section to part V to be appropriately		
6	designated and to read as follows:		
7	"§134- Location restrictions for electric guns. (a) It		
8	shall be unlawful for any person to carry or possesses an		
9	electric gun in or near an airport, passenger transportation		
10	terminal, commuter operations area, state or county government		
11	building, or any meeting place required to be open to the public		
12	pursuant to chapter 92; provided that the following shall be		
13	exempt:		
14	(1) Any person who possesses weapons in or transports		
15	weapons into a court of law to be used as evidence;		
16	provided that a person is not exempt if they are a		
17	party to an action pending before the court;		
18	(2) A full time paid peace officer of another state or the		
19	federal government who is carrying out official duties		
20	while in the State or any person summoned by the peace		
21	officer to assist in making arrests or preserving the		

1		peace while that person is engaged in assisting the
2		peace officer;
3	(3)	A person who has permission to possess an electric gun
4		in writing by a duly authorized official who is
5		charged with the security of a state or county
6		government building;
7	(4)	A person who lawfully resides in, owns, or is in
8		possession of a state or county government building
9		with respect to those portions of the building that
10		are not owned or leased by the state or county
11		government;
12	(5)	A person licensed or registered in accordance with,
13		and acting within the course and scope of chapter 463,
14		and who has been hired by the owner of a state or
15		county government building; and
16	(6)	Any person or agency exempt pursuant to section
17		134-87.
18	(b)	Any person violating this section shall be guilty of a
19	misdemeanor."
