# A BILL FOR AN ACT

RELATING TO RISK AND NEEDS ASSESSMENT FOR FEMALE OFFENDERS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

I	SECT	ION 1. Section 353-10, Hawaii Revised Statutes, is
2	amended b	y amending subsection (b) to read as follows:
3	"(b)	The centers shall:
4	(1)	Provide orientation, guidance, and technical services;
5	(2)	Provide social-medical-psychiatric-psychological
6		diagnostic evaluation;
7	(3)	Conduct internal pretrial risk assessments on adult
8		offenders within three working days of admission to a
9		community correctional center; provided that this
10		paragraph shall not apply to persons subject to county
11		or state detainers or holds, persons detained without
12		bail, persons detained for probation violation,
13		persons facing revocation of bail or supervised
14		release, and persons who have had a pretrial risk
15		assessment completed prior to admission to a community
16		correctional center. For purposes of this paragraph,
17		"pretrial risk assessment" means an objective,

research-based, validated assessment tool that
measures an offender's risk of flight, risk of
criminal conduct, and risk of violence or harm to any
person or the general public while on pretrial release
pending adjudication. The pretrial risk assessment
tool and procedures associated with its administration
shall be periodically reviewed and subject to further
validation at least every five years to evaluate the
effectiveness of the tool and the procedures
associated with its administration. The findings of
periodic reviews shall be publicly reported;
Conduct internal pretrial female risk and needs
assessments on adult female offenders within three
working days of admission to a community correctional
center; provided that this paragraph shall not apply
to persons subject to county or state detainers or
holds, persons detained without bail, persons detained
for probation violation, persons facing revocation of
bail or supervised release, and persons who have had a
pretrial female risk and needs assessment completed
prior to admission to a community correctional center.

2		shall consider factors important to evaluate a woman's
3		risk of reoffending, including but not limited to
4		rates of physical and sexual abuse prior to becoming
5		an offender, and a woman's specialized treatment
6		needs. The pretrial female risk and needs assessment
7		tool and procedures associated with its administration
8		shall be periodically reviewed and subject to further
9		validation at least every five years to evaluate the
10		effectiveness of the tool and the procedures
11		associated with its administration. The findings of
12		periodic reviews shall be publicly reported.
13		For purposes of this paragraph, "pretrial female
14		risk and needs assessment" means an objective,
15		research-based, validated assessment tool that
16		measures a female offender's risk of flight, risk of
17		criminal conduct, and risk of violence or harm to any
18		person or the general public while on pretrial release

2	pret	rial risk assessment delineating the scored items,
3	the	total score, any administrative scoring overrides
4	appl	ied, and written explanations for administrative
5	scor	ing overrides, shall be included in the pretrial
6	bail	report. The pretrial bail reports shall be
7	conf	idential and shall not be deemed to be public
8	reco	rds. A copy of a pretrial bail report shall be
9	prov	ided only:
10	(A)	To the defendant or defendant's counsel;
11	(B)	To the prosecuting attorney;
12	(C)	To the department of public safety;
13	(D)	To any psychiatrist, psychologist, or other
14		treatment practitioner who is treating the
15		defendant pursuant to a court order;
16	(E)	Upon request, to the adult client services
17		branch; and
18	(F)	In accordance with applicable laws, persons, or

PSD; Female Risk and Needs Assessment Tool; Correctional Facilities; Women's Correctional Centers; Female Inmates

Requires the department of public safety to develop a pretrial female risk and needs assessments tool and conduct internal female risk and needs assessments to measure female offenders' risk of flight, reoffending, or harm to the community. Requires the pretrial female risk and needs assessment tool to consider factors important to women when considering their risks of reoffending and their treatment needs. Effective 7/1/3000. (HD1)
