BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 PART I 2 SECTION 1. There are appropriated or authorized from the 3 sources of funding indicated below to collective bargaining 4 statewide (BUF 102) the following sums or so much thereof as may 5 be necessary to fund for fiscal biennium 2021-2023 all 6 collective bargaining cost items in the agreement negotiated 7 with the exclusive representative of collective bargaining 8 unit (8):

- 6 authorized by this Act that are not expended or encumbered by
- 7 June 30, 2023, shall lapse as of that date.
