# A BILL FOR AN ACT

RELATING TO PUBLIC EMPLOYMENT COST ITEMS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 PART I

2 SECTION 1. There are appropriated or authorized from the  
3 sources of funding indicated below to collective bargaining  
4 statewide (BUF 102) the following sums or so much thereof as may  
5 be necessary to fund for fiscal biennium 2021-2023 all  
6 collective bargaining cost items in the agreement negotiated  
7 with the exclusive representative of collective bargaining  
8 unit (11):

10 General funds	\$17,129	\$325,793
11 Special funds	\$63,853	\$1,232,362

12 SECTION 2. Funds appropriated or authorized by this part  
13 shall be allotted by the director of finance to the appropriate  
14 state departments for expenditure in the respective fiscal year  
15 for the purposes of this part.

17 SECTION 3. There are appropriated or authorized from the  
18 sources of funding indicated below to collective bargaining



1 statewide (BUF 102) the following sums or so much thereof as may  
2 be necessary to fund for fiscal biennium 2021-2023 the salary  
3 increases and other cost adjustments authorized by chapter 89C,  
4 Hawaii Revised Statutes, for state officers and employees who  
5 are excluded from collective bargaining and belong to the same  
6 compensation plans as those officers and employees within  
7 bargaining unit (11):

8 General funds	\$2,755	\$29,861
9 Special funds	\$9,446	\$102,987

11 SECTION 4. Funds appropriated or authorized by this part  
12 shall be allotted by the director of finance to the appropriate  
13 state departments for expenditure in the respective fiscal year  
14 for the purposes of this part.

15 PART III

16 SECTION 5. Salary increases and cost adjustments provided  
17 in this Act for any officer or employee whose compensation is  
18 paid, in whole or in part, from federal, special, or other funds  
19 shall be paid wholly or proportionately, as the case may be,  
20 from the respective funds.



1           SECTION 6. The fiscal year 2021-2022 appropriations or  
2 authorizations under this Act shall not lapse until the end of  
3 fiscal biennium 2021-2023; provided that funds appropriated or  
4 authorized by this Act that are not expended or encumbered by  
5 June 30, 2023, shall lapse as of that date.

6           SECTION 7. This Act shall take effect upon its approval.
