A BILL FOR AN ACT

RELATING TO HARBORS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that over eighty per cent
- 2 of goods in Hawaii are imported via ocean transportation. While
- 3 imported goods are offloaded at Honolulu harbor upon arrival,
- 4 many cargo containers are transported on commercial trucks to
- 5 west Oahu for storage or further processing. The high volume of
- 6 goods arriving at Honolulu harbor requires commercial trucks to
- 7 travel between Honolulu harbor and west Oahu several times a
- 8 day. Many items transported to west Oahu are then sent back to
- 9 urban Honolulu, creating increased traffic levels and
- 10 congestion. In order to ensure that Hawaii's supply chain
- 11 demands are met while alleviating commercial trucking traffic
- 12 congestion, a comprehensive study needs to be undertaken to
- 13 provide further information on increasing operations at Kalaeloa
- 14 harbor in west Oahu.
- 15 Therefore, the purpose of this Act is to require the
- 16 department of transportation harbors division to conduct a
- 17 comprehensive study to determine and identify resources

- 2 commercial uses, including offloading of cargo and livestock
- 3 transportation.
- 4 SECTION 2. The department of transportation harbors
- 5 division shall conduct a comprehensive study to examine
- 6 resources necessary to expand Kalaeloa harbor for additional
- 7 commercial use, including:
- 8 (1) Offloading of cargo containers; and
- 9 (2) Livestock transportation.
- 10 The study shall include traffic studies and feedback from
- 11 wholesale and transportation operators in the State.
- 12 SECTION 3. There is appropriated out of the general
- 13 revenues of the State of Hawaii the sum of \$ or so
- 14 much thereof as may be necessary for fiscal year 2022-2023 for a
- 15 comprehensive study examining increased commercial activity and
- 16 harbor usage at Kalaeloa harbor.
- 17 The sum appropriated shall be expended by the department of
- 18 transportation for the purposes of this Act.
- 19 SECTION 4. The department of transportation harbors
- 20 division shall submit a report of its findings and
- 21 recommendations, including any proposed legislation, to the



- 1 legislature no later than twenty days prior to the convening of
- 2 the regular session of 2023.
- 3 SECTION 5. This Act shall take effect on July 1, 2022.
