### A BILL FOR AN ACT

RELATING TO JUVENILE JUSTICE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the duties performed
- 2 by juvenile probation officers are essential and vital to the
- 3 State's juvenile justice system. Juvenile probation officers
- 4 address a wide range of complex issues that impact the
- 5 well-being of our youth and their families. Probation officers
- 6 work collaboratively with community-based partners to develop
- 7 and strengthen strategies and programs that offer solutions for
- 8 our State. Hawaii's juvenile probation officers are also
- 9 committed to practicing restorative justice and enhancing public
- 10 safety. Their efforts to transform our juvenile justice system
- 11 have resulted in a significant reduction in juvenile crime
- 12 across the State.
- 13 The legislature also finds that juvenile probation officers
- 14 are currently classified as social workers within the
- 15 judiciary's hiring system. This classification has created
- 16 confusion about the role and authority of juvenile probation
- 17 officers, including their ability to take minors into custody,

- 1 administer drug tests, and establish reporting requirements for
- 2 earned discharge from probation. Juvenile probation officers do
- 3 not currently have access to annual safety training and do not
- 4 possess sufficient identification, such as badges, to ensure
- 5 their safety in the field.
- 6 The purpose of this Act is to:
- 7 (1) Require the judiciary to create a separate employment
- 8 classification for juvenile probation officers;
- 9 (2) Establish minimum procedures for the appointment of
- juvenile probation officers; and
- 11 (3) Require a report from the judiciary to the legislature
- on the status of the implementation of this Act.
- 13 SECTION 2. Section 571-85, Hawaii Revised Statutes, is
- 14 amended to read as follows:
- 15 "§571-85 Authority of probation officers; additional
- 16 probation officers. (a) Within the scope of their duties,
- 17 probation officers appointed under this chapter shall have the
- 18 powers and privileges of a police officer. In addition to the
- 19 probation officers appointed under section 571-6, the judges of
- 20 the family courts may appoint special probation officers who
- 21 shall serve without pay but who shall be entitled to be

1 reimbursed for any cost or expense incurred by them in 2 connection with the performance of their duties as defined by 3 the judge. 4 All probation officers appointed under this chapter 5 shall: 6 Take an oath of office pursuant to the Hawaii state (1)7 constitution; 8 Be issued a certificate of appointment having the (2) 9 title "probation officer"; 10 Be issued individual badges and identification cards (3) 11 having the title "probation officer"; and 12 Complete an annual safety training course for which (4) 13 the curriculum has been approved by the judiciary." 14 SECTION 3. (a) The judiciary shall create a separate 15 employment classification for juvenile probation officers. All 16 juvenile probation officers already employed by the judiciary as of the effective date of this Act shall: 17 Have their status transferred to the new 18 (1)classification system no later than July 1, 2023; and 19 20 (2) Complete their first annual safety training course, as

required by section 571-85(b), Hawaii Revised

2	approval of the curriculum.
3	(b) The judiciary shall also consult with appropriate
4	labor representatives as specified in the applicable collective
5	bargaining agreement.
6	SECTION 4. No later than twenty days prior to the
7	convening of the 2023 and 2024 regular sessions, the judiciary
8	shall submit a report to the legislature on the status of the
9	judiciary's implementation of this Act.
10	SECTION 5. New statutory material is underscored.
11	SECTION 6. This Act shall take effect upon its approval.
