A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF HUMAN SERVICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The purpose of this Act is to ensure the

4	human services through consistent and continuous funding of

7	by the State of Hawaii from the American Rescue Plan Act, Public									
8	Law 117-2, Section 9901, for the department of human services

- 11 SECTION 5. This Act shall take effect on July 1, 2022.
