A BILL FOR AN ACT

RELATING TO A SCHOOL SUPPLY SUBSIDY PILOT PROGRAM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Title I, Part A, of
- 2 the Elementary and Secondary Education Act, as amended by the
- 3 Every Student Succeeds Act (Title I), provides federal financial
- 4 assistance to local educational agencies and schools with high
- 5 percentages of children from low-income families to help ensure
- 6 educational success. The legislature further finds that a pilot
- 7 program to subsidize school supplies for schools composed
- 8 entirely of students eligible for participation in Title I would
- 9 be useful to identify methods for relieving the financial burden
- 10 of education on low-income families.
- 11 As a school composed entirely of students eligible for
- 12 participation in Title I, the legislature identifies Na'alehu
- 13 elementary school for a pilot program. The legislature further
- 14 finds that many students who attend Na'alehu elementary school
- 15 live in rural areas across Ka'ū and experience geographical
- 16 challenges, such as limited opportunities and isolation from
- 17 educational resources.

1 The legislature further finds that, based on the school 2 supplies list for the 2021-2022 school year at Na'alehu 3 elementary school and the average cost of school supplies at 4 local stores, the cost for school supplies by grade are as 5 follows: grade one, \$4,451.58; grade two, \$1,605.86; grade 6 three, \$3,646.08; grade four, \$5,186.94; grade five, \$4,913.63; 7 and grade six, \$3,969. 8 The legislature additionally finds that, despite the 9 current economic situation, Hawai'i's schools should focus 10 resources on retaining and developing those qualified teachers, 11 support staff, and administrators who collaborate to create and 12 sustain the successful learning environments necessary to 13 graduate every student. 14 The purpose of this Act is to establish and make an 15 appropriation for a one-year school supply subsidy pilot program 16 at Na'alehu elementary school. 17 SECTION 2. (a) Beginning with the 2022-2023 school year, 18 the department of education shall establish and implement a one-19 year school supply subsidy pilot program at Na'alehu elementary 20

school.

1	(b) The department of education shall submit a report of
2	its findings and recommendations regarding the school supply
3	subsidy pilot program, including any proposed legislation, to
4	the legislature no later than twenty days prior to the convening
5	of the regular session of 2024.
6	SECTION 3. There is appropriated out of the general
7	revenues of the State of Hawaii the sum of \$ or so
8	much thereof as may be necessary for fiscal year 2022-2023 to
9	establish and implement a one-year school supply subsidy pilot
10	program at Na'alehu elementary school.
11	The sum appropriated shall be expended by the department of
12	education for the purposes of this Act.
13	SECTION 4. This Act shall take effect on July 1, 2022, and
14	shall be repealed on January 1, 2024.
