A BILL FOR AN ACT

RELATING TO HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the purpose of "One
- 2 Shared Vision" is to establish closer professional interactions,
- 3 collaborations, and educational opportunities across the various
- 4 health, medical, specialty, social service, and environmental
- 5 health professions to simultaneously improve public health. In
- 6 response to the 2018 Kilauea eruption, the State, Hawaii county,
- 7 and non-profit agencies bonded in solidarity to provide
- 8 essential relief and services to affected residents. This
- 9 cooperative model resulted in sustained trust and partnering.
- 10 Health is a complex issue that requires examination of the
- 11 social determinants that involve continuous availability of
- 12 resources and coordinated efforts at all levels. The
- 13 legislature finds that the establishment of a strong health
- 14 network based in Hawaii county would allow the county to serve
- 15 as a model of collaboration for other areas. The success of
- 16 such a health network will result in Hawaii county plan, being
- 17 able to efficiently develop a ten-year health care, including

- 1 preventative and primary health care, specialty care, and urgent
- 2 and emergency care.
- 3 The purpose of this Act is to:
- 4 (1) Require the office of primary care and rural health to facilitate discussions with key community health and
- 6 social service organizations within Hawaii county to
- 7 address the health and wellness needs of the most
- 8 vulnerable by aligning the goals and objectives of key
- 9 organizations into a 2030 one shared health vision
- 10 plan; and
- 11 (2) Require a report to the legislature.
- 12 SECTION 2. (a) The office of primary care and rural
- 13 health shall initiate a 2030 one shared health vision plan. A
- 14 pilot program shall be conducted in Hawaii county.
- 15 (b) The office of primary care and rural health shall
- 16 facilitate discussions with key community health and social
- 17 service organizations within Hawaii county to address the health
- 18 and wellness needs of the most vulnerable by aligning the goals
- 19 and objectives of appropriate community service providers.
- 20 (c) The office of primary care and rural health shall
- 21 submit a report on the 2030 one shared health vision plan for

- 1 Hawaii county, including any proposed long-term legislative
- 2 grant-in-aid requests, to the legislature no later than twenty
- 3 days prior to the convening of the regular session of 2023.
- 4 SECTION 3. This Act shall take effect upon its approval.
