BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

16	(4)	Establish standards that shall apply to the healthy

There is established a healthy soils grant program 2 special fund to be placed in the department of agriculture for administrative purposes into which shall be deposited any 3 4 appropriations by the legislature. The fund shall be used to 5 implement and operate the healthy soils grant program and award 6 grants. 7 The department of agriculture shall submit a report (d) 8 detailing the status and progress of the healthy soils grant 9 program, including any proposed legislature or recommendations, 10 to the legislature no later than twenty days prior to the 11 convening of each regular session." SECTION 2. There is appropriated out of the general fund 12 the sum of \$ or so much thereof as may be necessary 13 14 for fiscal year 2022-2023 to be deposited into the healthy soils grant program special fund. 15 16 SECTION 3. There is appropriated out of the healthy soils grant program special fund the sum of \$ or so much 17 thereof as may be necessary for fiscal year 2022-2023 for the 18 establishment of the health soils grant program and to award 19 20 grants pursuant to the program.

- 1 The sum appropriated shall be expended by the department of
- 2 agriculture for the purposes of this Act.

- 4 SECTION 5. This Act shall take effect on July 1, 2022.
