#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

### JUSTIFICATION SHEET

DEPARTMENT:

Accounting and General Services - ETS

TITLE:

A BILL FOR AN ACT RELATING TO THE INFORMATION PRIVACY AND SECURITY COUNCIL.

PURPOSE:

To allow each member of the Information and Privacy Security Council (IPSC) to designate a person from that member's agency to attend a meeting and act on the member's behalf in the event the appointed member cannot attend a meeting, in order to ensure that a quorum is present.

MEANS:

Amend section 487N-5, Hawaii Revised Statutes (HRS).

JUSTIFICATION:

The IPSC is often unable to meet quorum. IPSC members, consisting solely of state and county employees, are often unable to attend IPSC meetings due to work related emergencies and other work priorities. As a result, key discussion and decision making on items such as the annual summary report to the Legislature required by section 487N-5, HRS, and the personal information system annual reports, required by section 487N-7, HRS, are delayed. Allowing IPSC members to designate a person to act on the member's behalf will alleviate these challenges.

Impact on the public: Would allow the public's privacy concerns to be discussed and acted upon for decision-making.

Impact on the department and other agencies:
The appointed member would select a designee from the agency for representation on the IPSC in the event the appointed member is unable to attend the meeting.
