# A BILL FOR AN ACT

RELATING TO THE HAWAII FILM AND CREATIVE INDUSTRIES DEVELOPMENT SPECIAL FUND.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. Section 201-113, Hawaii Revised Statutes, is
2	amended to	o read as follows:
3	"§20	1-113 Hawaii film and creative industries development
4	special f	und. (a) There is established in the state treasury
5	the Hawai	i film and creative industries development special fund
6	into which	h shall be deposited:
7	(1)	Appropriations by the legislature;
8	(2)	Donations and contributions made by private
9		individuals or organizations for deposit into the
10		fund;
11	(3)	Grants provided by governmental agencies or any other
12		source; [and]
13	(4)	Effective January 2, 2021, all revenues, fees, and
14		charges from the processing of the motion picture,
15		digital media, and film production income tax credit
16		pursuant to section 235-17[-]; and

1	<u>(5)</u>	Effective July 1, 2022, all revenues, fees, and income
2		received by the department from its management of
3		public facilities that support media and entertainment
4		workforce and business development, with the exception
5		of the Hawaii film studio.
6	(b)	The fund shall be used by the department to provide
7	for:	
8	(1)	A program to provide seed capital for film, media, and
9		creative industries intellectual property development
10		projects for export, as determined by the department;
11	(2)	Programs that expand the skills of the State's resident
12		workforce in the film, media, and creative industries;
13		[ <del>and</del> ]
14	(3)	Marketing programs that attract business opportunities
15		[within] in the film, media, and creative industries
16		in the State[-]; and
17	(4)	Repair, maintenance, and related costs of the
18		department's management of public facilities that
19		support media and entertainment workforce and business
20		development."

- 6 The sum appropriated shall be expended by the department of
