## A BILL FOR AN ACT

RELATING TO OPTIONS FOR STUDENTS IN DEPARTMENT OF EDUCATION SCHOOLS.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to provide clarity
- 2 and consistency with regard to commercial enterprise activities
- 3 in schools by:
- 4 (1) Broadening the scope of profit-making operations
- 5 students may engage in at schools to include
- 6 commercial enterprises, while ensuring that engagement
- 7 in commercial enterprises shall be related to the
- 8 primary educational purposes of the school, career
- 9 pathway, academy, or program as required by section
- 10 302A-448, Hawaii Revised Statutes; and
- 11 (2) Allowing students to receive school credit,
- compensation, or both, when engaging in profit-making
- operations.
- 14 SECTION 2. Section 302A-420, Hawaii Revised Statutes, is
- 15 amended to read as follows:
- 16 "§302A-420 Profits [to pupils.] and school credit for
- 17 students. All net profits arising from agricultural [and],
