BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to allow for greater

- 3 deeming student interns to be employees of the state and (2)
- 4 allowing the department of education to use revenue from school
- 5 commercial enterprises.
- 6 SECTION 2. Section 302A-448, Hawaii Revised Statutes, is
- 7 amended to read as follows:
- 8 "[+]§302A-448[+] Schools; career pathways, academies, and
- 9 programs; commercial enterprises. (a) Notwithstanding any law
- 10 to the contrary, an individual department school or any career
- 11 pathway, academy, or program operated within a school may engage
- 12 in commercial enterprises that are related to the primary
- 13 educational purposes of the school, career pathway, academy, or
- 14 program as set forth in this chapter, including the sale of
- 15 goods produced by or for an individual school, career pathway,
- 16 academy, or program.

JUSTIFICATION SHEET

DEPARTMENT: Education

TITLE: A BILL FOR AN ACT RELATING TO COMMERCIAL

ENTERPRISES IN SCHOOLS

PURPOSE: To deem student interns engaging in

commercial enterprises to be employees of the State of Hawaii; provide increased flexibility for programs that train

students; allow the Department of Education (Department) to use revenue from school

commercial enterprises.

MEANS: Amends section 302A-448, Hawaii Revised

Statutes (HRS).

JUSTIFICATION: This measure addresses the liability issue

that a business could face when employing a student intern through the commercial enterprise program. It would provide some degree of protection for businesses in situations where a student intern is injured

or causes an injury while working for a business as part of the commercial

enterprises program, and would thus help to further facilitate business participation in

the commercial enterprise program.

Additionally, while section 302A-448, HRS, allows for schools to create commercial enterprises, schools are finding it difficult to move forward with commercial enterprises due to a mix of regulatory hurdles and funding shortfalls. This measure addresses these issues by allowing revenue generated from school commercial enterprises to be reinvested by the Department and allowing for exemptions from other regulatory practices.

If partnerships can be facilitated via the increased flexibility provided by this

measure and the increased protections for business partners, the rigor and relevance of work-based learning throughout the preschool through higher education continuum will be strengthened as students engage in comprehensive, real-world immersive experiences.

Impact on the public: Provide increased internship opportunities that benefit students and industry.

Impact on the department and other agencies:

If the Department can successfully implement training partnerships, other agencies could use this measure's framework to realize similar workforce development outcomes.
