A BILL FOR AN ACT

RELATING TO HAWAIIAN HOME LANDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that in 2019,
- 2 approximately 28,500 native Hawaiian adults were on the
- 3 department of Hawaiian home lands application waiting list for
- 4 residential, farming, or ranching homesteads. The homelessness
- 5 crisis in Hawaii is already serious, with Hawaii ranking third
- 6 in the country among states with the most homeless people per
- 7 ten thousand residents in 2020. The waiting list backlog
- 8 exacerbates this crisis that already disproportionately affects
- 9 native Hawaiians.
- 10 The legislature further finds that even at the end of 2021,
- 11 the number of native Hawaiians on the waiting list has not
- 12 significantly decreased despite plans to develop more Hawaiian
- 13 home lands lots. To date, more than two thousand native
- 14 Hawaiian beneficiaries have died while on the waiting list.
- 15 Furthermore, due to the coronavirus disease 2019 pandemic, those
- 16 on the waiting list who are not homeless are struggling to pay
- 17 rent to the extent where a federal government stimulus package

- 1 offered relief specifically for native Hawaiians on the waiting
- 2 list for homestead leases. The department of Hawaiian home
- 3 lands must ameliorate this situation.
- 4 The legislature also finds that according to the department
- 5 of Hawaiian home lands 2020 Beneficiaries Study Applicant
- 6 Report, seventy-six per cent of department of Hawaiian home
- 7 lands applicants on the waiting list would prefer a lot with a
- 8 single-family home or vacant lot for a house, while sixteen per
- 9 cent would like a rental single-family home, duplex, apartment,
- 10 or townhouse, with the option to buy.
- 11 The purpose of this Act is to require the department of
- 12 Hawaiian home lands to address the housing requirements of those
- 13 applicants on the department's waiting list by developing a
- 14 strategic plan to address those applicants with a preference for
- 15 a single-family home or vacant lots and those applicants with a
- 16 preference for rental housing, including apartment units and
- 17 rent-with-option-to-buy housing units.
- 18 SECTION 2. (a) The department of Hawaiian home lands
- 19 shall develop a strategic plan to meet the following applicant
- 20 preferences:

1	(1)	Seventy-six per cent of individuals on the department
2		of Hawaiian home lands waiting list who prefer a lot
3		with a single-family home or a vacant lot for a house;

5	(2)	Sixteen per cent of individuals on the department of
6		Hawaiian home lands waiting list who prefer to rent or
7		rent-to-own a single-family home, duplex, apartment,
8		or townhouse, with the option to buy in the future.
9	(b)	The strategic plan shall be divided by county and
10	include r	ecommended waiting list policies detailing when
11	homeowner	-applicants receive mortgage or down payment assistance
12	from the	department of Hawaiian home lands and renter-applicants
13	opt to li	ve in rental housing developed by the department of
14	Hawaiian	home lands.
15	(c)	The department of Hawaiian home lands shall submit the
16	strategic	plan, including findings, recommendations, and any
17	proposed	legislation, to the legislature no later than
18	December	10, 2022.
19	SECT	ION 3. This Act shall take effect on January 1, 2222.
