A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE BENEFIT OF THE
ELEVENTH SENATORIAL DISTRICT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The director of finance is authorized to issue general obligation bonds in the sum of \$24,900,000 or so much thereof as may be necessary, and the same sum or so much thereof as may be necessary is appropriated for fiscal year 2022-2023 for the purpose of capital improvement projects for the eleventh senatorial district, as follows:


4 SECTION 2. The appropriations made for the capital
5 improvement projects authorized by this Act shall not lapse at
6 the end of the fiscal year for which the appropriations are
7 made; provided that all moneys from the appropriations that are
8 unencumbered as of June 30, 2024, shall lapse as of that date.

9 SECTION 3. The sums appropriated for the capital
10 improvement projects set forth in section 1 shall be expended by
11 the department of education for the purposes of this Act.

12 SECTION 4. This Act shall take effect on July 1, 2022.
