A BILL FOR AN ACT

PROPOSING AMENDMENTS TO THE HAWAII CONSTITUTION TO ESTABLISH A HAWAII COMMUNITY COLLEGE SYSTEM THAT IS SEPARATE FROM THE UNIVERSITY OF HAWAII.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to propose
- 2 amendments to article X of the Constitution of the State of
- 3 Hawaii to establish a Hawaii community college system, which
- 4 shall be separate from the University of Hawaii.
- 5 SECTION 2. Article X of the Constitution of the State of
- 6 Hawaii is amended by adding two new sections to be appropriately
- 7 designated and to read as follows:

8 "HAWAII COMMUNITY COLLEGE SYSTEM

- 9 Section . The Hawaii community college system is hereby
- 10 established and constituted a body corporate. It shall have
- 11 jurisdiction over all public community colleges in the State.
- 12 It shall have title to all the real and personal property now or
- 13 hereafter set aside or conveyed to it, which shall be held in
- 14 public trust for its purposes, to be administered and disposed
- 15 of as provided by law.



1 BOARD OF REGENTS OF THE HAWAII COMMUNITY COLLEGE SYSTEM; POWERS 2 Section . There shall be a board of regents of the Hawaii 3 community college system, the members of which shall be 4 nominated and, by and with the advice and consent of the senate, 5 appointed by the governor from pools of qualified candidates 6 presented to the governor by the candidate advisory council for 7 the boards of regents of the University of Hawaii and Hawaii 8 community college system, as provided by law. At least part of 9 the membership of the board shall represent geographic 10 subdivisions of the State. The board shall have the power to 11 formulate policy and to exercise control over the community 12 college system through its executive officer, the president of 13 the community college system, who shall be appointed by the 14 board. The board shall also have exclusive jurisdiction over the internal structure, management and operation of the 15 16 community college system. This section shall not limit the

4	Section 1. The State shall provide for the establishment,
5	support and control of a statewide system of public schools free
6	from sectarian control, [a state university,] the University of
7	Hawaii, the Hawaii community college system, public libraries
8	and [such] other educational institutions as [may be] deemed
9	desirable, including physical facilities therefor. There shall
10	be no discrimination in public educational institutions because
11	of race, religion, sex or ancestry; nor shall public funds be
12	appropriated for the support or benefit of any sectarian or
13	nonsectarian private educational institution, except that
14	proceeds of special purpose revenue bonds authorized or issued
15	under section 12 of Article VII may be appropriated to finance
16	or assist:
17	1. Not-for-profit corporations that provide early
18	childhood education and care facilities serving the general
19	public; and

- 1 2. Not-for-profit private nonsectarian and sectarian
- 2 elementary schools, secondary schools, colleges and
- 3 universities."
- 4 SECTION 4. Article 10, section 5, of the Constitution of
- 5 the State of Hawaii is amended to read as follows:
- 6 "UNIVERSITY OF HAWAII
- 7 Section 5. The University of Hawaii is hereby established
- 8 as [the] a state university and constituted a body corporate.
- 9 It shall have jurisdiction over the State's public institutions
- 10 of higher education, except for the community colleges. It
- 11 shall have title to all the real and personal property now or
- 12 hereafter set aside or conveyed to it, which shall be held in
- 13 public trust for its purposes, to be administered and disposed
- 14 of as provided by law."
- 15 SECTION 5. Article 10, section 6, of the Constitution of
- 16 the State of Hawaii is amended to read as follows:
- 17 "BOARD OF REGENTS[;] OF THE UNIVERSITY OF HAWAII; POWERS
- 18 Section 6. There shall be a board of regents of the
- 19 University of Hawaii, the members of which shall be nominated
- 20 and, by and with the advice and consent of the senate, appointed
- 21 by the governor from pools of qualified candidates presented to



- 1 the governor by the candidate advisory council for the [board]
- 2 boards of regents of the University of Hawaii $[\tau]$ and Hawaii
- 3 community college system, as provided by law. At least part of
- 4 the membership of the board shall represent geographic
- 5 subdivisions of the State. The board shall have the power to
- $\mathbf{6}$ formulate policy[τ] and to exercise control over the university
- 7 through its executive officer, the president of the university,
- 8 who shall be appointed by the board. The board shall also have
- 9 exclusive jurisdiction over the internal structure,
- 10 management $[\tau]$ and operation of the university. This section
- 11 shall not limit the power of the legislature to enact laws of
- 12 statewide concern. The legislature shall have the exclusive
- 13 jurisdiction to identify laws of statewide concern."
- 14 SECTION 6. The question to be printed on the ballot shall
- 15 be as follows:
- 16 "Shall the community colleges of the State of Hawaii be
- 17 administered as a separate Hawaii Community College System,
- 18 which shall be independent from the University of Hawaii
- and administered by a separate board of regents?"
