13	(1)	For solicitations issued pursuant to section 103D-302,
14		the contract may be awarded to the next lowest bidder;
15		provided that all prices remain the same as originally

17	(2)	For solicitations issued pursuant to section 103D-303,
18		the contract may be awarded to the next responsible
19		offeror whose proposal is determined in writing to be
