BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that campaign fundraiser
- 2 events held during legislative sessions diminish the public
- 3 trust.
- 4 The purpose of this Act is to prohibit elected state and
- 5 county officials from holding fundraiser events to raise
- 6 contributions for which any price is charged or any contribution
- 7 is suggested for attendance during regular or special sessions
- 8 of the state legislature.
- 9 SECTION 2. Section 11-342, Hawaii Revised Statutes, is
- 10 amended to read as follows:
- "[+] \$11-342[+] Fundraiser; fundraiser event; notice of
- 12 intent[-]; when prohibited. (a) No fundraiser shall be held
- 13 unless a notice of intent to hold the fundraiser is filed with
- 14 the commission setting forth the name and address of the person
- 15 in charge, the price per person, the date, hour, and place of
- 16 the fundraiser, and the method thereof.
