A BILL FOR AN ACT

RELATING TO THE COMMISSION ON WATER RESOURCE MANAGEMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that section 174C-101(a),
- 2 Hawaii Revised Statutes, provides that decisions of the
- 3 commission on water resource management relating to the
- 4 planning, regulation, management, and conservation of water
- 5 resources in the State shall, to the extent applicable and
- 6 consistent with other legal requirements and authority,
- 7 incorporate and protect adequate reserves of water for current
- 8 and foreseeable development and use of Hawaiian home lands as
- 9 set forth in section 221 of the Hawaiian Homes Commission Act.
- 10 The purpose of this Act is to add the chairperson of the
- 11 Hawaiian homes commission or the chairperson's designated
- 12 representative as an ex officio, nonvoting member to the
- 13 commission on water resource management to advance the interest
- 14 of beneficiaries of the Hawaiian Homes Commission Act.
- 15 SECTION 2. Section 174C-7, Hawaii Revised Statutes, is
- 16 amended by amending subsections (a) and (b) to read as follows:



1 "(a) There is established within the department a 2 commission on water resource management consisting of seven 3 voting members [which] that shall have exclusive jurisdiction and final authority in all matters relating to implementation 4 5 and administration of the state water code, except as otherwise 6 specifically provided in this chapter. 7 Five members shall be appointed by the governor 8 subject to confirmation by the senate in the manner prescribed 9 in subsection (d). Each member, excluding the ex officio 10 members, shall have substantial experience in the area of water 11 resource management; provided that at least one member shall 12 have substantial experience or expertise in traditional Hawaiian 13 water resource management techniques and in traditional Hawaiian 14 riparian usage such as those preserved by section 174C-101. 15 chairperson of the board of land and natural resources shall be the chairperson of the commission. The director of health or 16 17 the director's designee shall serve as an ex officio[+],[+] 18 voting member. The chairperson of the Hawaiian homes commission 19 or the chairperson's designee shall serve as an ex officio, 20 nonvoting member."
