
SENATE CONCURRENT RESOLUTION

REQUESTING THAT THE DEPARTMENT OF TRANSPORTATION PREPARE A
PROPOSED LIST AND PRIORITIZE PROJECTS TO CREATE SAFE ROUTES
FOR SENIOR CITIZENS LIVING IN HOUSING UNITS, RENTALS,
HOTELS, CONDOMINIUMS, AND RESIDENTIAL PLACES STATEWIDE.

1 WHEREAS, independent living capabilities for Hawaii's
2 senior population continues to be an integral component for
3 health, longevity, and quality of life; and
4

5 WHEREAS, the liberty of movement, travel, and matriculation
6 promote and increase a senior citizen's sense of individual
7 autonomy; and
8

9 WHEREAS, access to pedestrian-safe walkways, pathways,
10 roadways, and other means of travel are essential for trade,
11 commerce, resource gathering, and economic activity; and
12

13 WHEREAS, senior citizen pedestrians may have reduced
14 physical abilities requiring assistive mobility devices, along
15 with losses in hearing, vision, and reflexes that impede safe
16 travel along pathways; and
17

18 WHEREAS, senior citizens may be more susceptible to slips,
19 trips, and falls, due to elevation changes in walkways,
20 pathways, and on uneven or slick surfaces; and
21

22 WHEREAS, in certain areas, senior living homes and
23 residences are located in close proximity to major thoroughfares
24 and highways, thereby increasing risk of personal injury and
25 individual safety; and

27 WHEREAS, senior citizens are more likely to need emergency
28 medical care when involved in traffic injuries with motor
29 vehicles and propelled devices, and have a significantly higher
30 fatality rate in the State; now, therefore,

2 BE IT RESOLVED by the Senate of the Thirty-first
3 Legislature of the State of Hawaii, Regular Session of 2022, the
4 House of Representatives concurring, that the Department of
5 Transportation is requested to create pedestrian-safe routes and
6 pathways that lead to and from places of residence in such a
7 manner that adheres to the unique needs of the senior citizen
8 population; and

10 BE IT FURTHER RESOLVED that the Department of
11 Transportation is requested to work with elected legislators
12 from each community to create a proposed list of pedestrian
13 projects and prioritize their construction while incorporating
14 statewide transportation plans, regional transportation plans,
15 and funding opportunities as may be necessary for their
16 construction; and

18 BE IT FURTHER RESOLVED that the Department of
19 Transportation is requested to consider the scope of this
20 request to be a statewide implementation of the aforementioned
21 subject areas, including the development and implementation of
22 comprehensive safety protocols that identify barriers to safe
23 mobility for the senior citizen population, and seek to provide
24 educational resources to the public regarding road and sidewalk
25 safety; and

27 BE IT FURTHER RESOLVED that the Department of
28 Transportation is requested to submit a report of its findings
29 and recommendations, including any proposed legislation, to the
30 Legislature no later than twenty days prior to the convening of
31 the Regular Session of 2023; and

33 BE IT FURTHER RESOLVED that a certified copy of this
34 Concurrent Resolution be transmitted to the Director of
35 Transportation.
