SENATE RESOLUTION

REQUESTING THE AUDITOR TO CONDUCT A COMPREHENSIVE PERFORMANCE
AND MANAGEMENT AUDIT OF THE CHILD WELFARE SERVICES BRANCH
OF THE DEPARTMENT OF HUMAN SERVICES.

1 WHEREAS, the purpose of the Child Welfare Services Branch
2 (CWSB) of the Department of Human Services is to:

3
4 (1) Ensure the safety, stability, and well-being of
5 children in the State; and

6
7 (2) Respond to allegations of child abuse and neglect
8 while providing supportive services to children and
9 their families; and

10
11 WHEREAS, due to recent tragic events, the public and news
12 media have raised many questions about the CWSB's operations,
13 including policies, procedures, and management; and

14
15 WHEREAS, a 2017 review conducted by the United States
16 Administration for Children and Families concluded that CWSB
17 made no improvements from the previous evaluation conducted in
18 2009; and

19
20 WHEREAS, CWSB was determined to not be in "substantial
21 conformity" with any of the seven outcome categories of the
22 evaluation, including the outcome that "[c]hildren are first and
23 foremost protected from abuse and neglect"; and

24
25 WHEREAS, CWSB only met five of the seven systematic factor
26 categories, an identical result to the 2009 evaluation; and

27
28 WHEREAS, attracting and retaining qualified employees has
29 been a significant, long-standing concern for CWSB; and

30
31 WHEREAS, other concerns include insufficient quality and
32 frequency of caseworker visits, children remaining in foster
33 care beyond fifteen months with no viable goal, and maltreatment
34 allegations in pending cases not formally being investigated;

2 WHEREAS, this body recognizes child abuse and neglect as
3 serious problems and that there is an urgent need to determine
4 whether CWSB has the personnel and resources necessary to
5 effectively investigate allegations of abuse and neglect, and
6 otherwise perform CWSB's duties; now, therefore,

8 BE IT RESOLVED by the Senate of the Thirty-first
9 Legislature of the State of Hawaii, Regular Session of 2022,
10 that the Auditor is requested to conduct a comprehensive
11 performance and management audit of the CWSB; and
12

13 BE IT FURTHER RESOLVED that the Auditor is requested to
14 examine, as part of the audit, the effectiveness of and
15 compliance with the CWSB's policies and procedures, including:
16

- 17 (1) Investigating and substantiating reports of child
18 abuse and neglect;
19
- 20 (2) Providing services for substantiated cases of child
21 abuse and neglect, including risk assessment methods
22 to assess whether the child is in danger of abuse or
23 neglect;

- 25 (3) Establishing, maintaining, and enforcing policies that
26 safeguard the rights of the child and their non-abuser
27 family members;

- 29 (4) Sharing information and coordinating investigative
30 duties with county police departments;
31
- 32 (5) Sharing information and coordinating duties with the
33 Department of the Attorney General Family Law
34 Division's policies and procedures;

- 36 (6) Inputting and maintaining the records in the Child
37 Abuse and Neglect Registry database; and

- 39 (7) Providing effective oversight and supervision of all
40 child welfare offices in the State; and

1 BE IT FURTHER RESOLVED that the Auditor is requested to
2 examine and provide recommendations for additional personnel and
3 other resources needed for the CWSB to effectively investigate
4 allegations of abuse, and neglect, and otherwise perform CWSB's
5 duties; and

7 BE IT FURTHER RESOLVED that the Auditor is requested to
8 submit a report of the Auditor's findings and recommendations,
9 including any proposed legislation, to the Legislature no later
10 than forty days prior to the convening of the Regular Session of
11 2023; and

12
13 BE IT FURTHER RESOLVED that certified copies of this
14 Resolution be transmitted to the Director of Human Services and
15 Administrator of the Child Welfare Services Branch of the
16 Department of Human Services.
