Your Committee on Economic Development, to which was referred H.B. No. 555, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO CONSUMER PROTECTION,"

begs leave to report as follows:

The purpose of this measure is to:

- Require retailers of household appliances to conspicuously display available energy efficiency rebates funded by the public benefits fee and statespecific energy operation costs;
- (2) Direct the Public Benefits Fee Administrator to create and update the template to be used by retailers; and
- (3) Require the Hawaii State Energy Office to publish signage requirements for household appliances on its website and provide a draft notification letter to the Public Benefits Fee Administrator to be distributed to retailers.

Your Committee received testimony in support of this measure from the Blue Planet Foundation, Hawai'i Energy, and Climate Protectors Hawaii. Your Committee received testimony in opposition to this measure from the Retail Merchants of Hawaii.

Your Committee received comments on this measure from the Hawaii State Energy Office and Public Utilities Commission.
