Your Committee further finds that Albert and Lawrence Manliguis, together, coached forty-eight consecutive seasons at Hilo High School, where they led the Hilo High School Vikings to three state championships during that time, with two state championships coached by Lawrence Manliguis and one state championship coached by Albert Manliguis. Your Committee believes that it would be fitting to name Hilo High School Gym after Albert
