"A BILL FOR AN ACT RELATING TO PUBLIC LANDS,"

The purpose of this measure is to exempt non-ceded lands set aside by the Governor to the Hawaii Housing Finance and Development Corporation from classification as public lands subject to Department of Land and Natural Resources management.

Your Committees received testimony in support of this measure from the Hawaii Housing Finance and Development Corporation. Your Committees received testimony in opposition to this measure from the Koʻolaupoko Hawaiian Civic Club and Ka Leo O Nā 'Ōpio.
