Your Committee finds that students who participate in commercial enterprises may gain hands-on and real-world experiences that are vital for post-secondary education and success in the workforce. Your Committee also finds that revenues generated from these enterprises can support various school programs. Your Committee recognizes that deeming student interns of commercial enterprises to be employees of the State would provide some degree of protection for businesses and thus encourage their participation in the commercial enterprise program. This will enable more schools to offer students the opportunity to participate in those enterprises.

Your Committee has amended this measure by making technical nonsubstantive changes for purposes of clarity, consistency, and style.
