Your Committee on Education, to which was referred S.C.R. No. 13 entitled:

"SENATE CONCURRENT RESOLUTION REQUESTING THE LEGISLATIVE REFERENCE BUREAU TO CONDUCT A STUDY ON THE FEASIBILITY OF THE STATE ESTABLISHING A UNIVERSAL, NO-COST PRE-KINDERGARTEN PROGRAM,"

begs leave to report as follows:

The purpose and intent of this measure is to request the Legislative Reference Bureau to conduct a study on the feasibility of the State establishing a universal, no-cost pre-kindergarten program.

Your Committee received testimony in support of this measure from one individual. Your Committee received comments on this measure from the Early Learning Board, Legislative Reference Bureau, Executive Office on Early Learning, and Early Childhood Action Strategy.

Your Committee finds that early learning programs provide a wide spectrum of benefits to children and society at-large. Your Committee further finds, however, that for many, program tuition is cost-prohibitive. Your Committee additionally finds that a handful of states have expanded access to early learning benefits to all children through a universal, no-cost pre-kindergarten program. Accordingly, this measure requests the Legislative

Reference Bureau to study the feasibility of a universal, no-cost pre-kindergarten program.
