Dear Dr. Anderson:

Thank you for your July 29 response to the committee's questions relating to contact tracing. We would appreciate a response to the follow-up questions at our briefing on August 6:

DOH DOCD Case Investigation Procedures:

- Provide a flowchart describing the elements of the disease case investigation process, including but not limited to:
 - o Report of a positive test result,
 - o Contact with positive individual,
 - o Case Investigation,
 - o Follow up contact, and
 - Reporting

Staffing:

- Of the 105 active Contact Tracers¹ reporting to DOH DOCD, how many:
 - o Conduct case investigation
 - o Provide data/communication support
 - o Provide administrative or other support
- What is the optimum ongoing caseload for a case investigator?
 - What is the maximum caseload for a case investigator?
- What conditions would trigger a decision to mobilize the additional 196 DOH contact tracers?
 - What would trigger mobilizing the full 450 person cohort of UH trained contact tracers?
- Update on the expenditure of state and federal funds for training, office space, and equipment for the newly onboarded Contract Tracers

<u>Data management</u>, analysis, and reporting: Update on the expenditure of state and federal funds for improved data management, analysis, and reporting.
