HB 1568, HD2 RELATING TO AGRICULTURE. AEN/GVO, WAM

(HSCR835-22)
Status & Changes the law requiring all state departments to ensure that a certain percentage of food purchased consists of fresh, local agricultural products or local value-added, processed,

Testimony agricultural, or food products to apply only to the DOE, DOH, PSD, DOD, and UH System. Requires each of those

departments and the UH System to report to the legislature on its progress toward meeting these benchmarks and clarifies the

information to be reported. Effective 7/1/2112. (HD2)

HB 2423, HD1 RELATING TO CLIMATE CHANGE MITIGATION. GVO/AEN,
Requires all state building construction projects and state JDC/WAM

(HSCR830-22)
Requires all state building construction projects and state highway projects to use building and construction materials that seek to reduce their carbon footprint, where feasible and cost
