Status Amends the composition of the Board of Agriculture by providing representation from the islands of Molokai and Lanai.

<u>HB 2280</u> RELATING TO REAL PROPERTY. AGR, CPC

Status Specifies that planned community associations cannot prohibit or unreasonably restrict the use of a unit owner's enclosed yard area for

personal agriculture.

DECISION MAKING TO FOLLOW
