HB 1980, HD2, SD1 RELATING TO TELEPHONIC SERVICES. HTH, CPN/WAM

(SSCR3368)

Requires Medicaid, health insurers, mutual benefit societies, and health maintenance organizations to cover services provided through telehealth by way of an interactive telecommunications system. Defines "interactive"

telecommunications system" to match the 2022 Medicare physician fee schedule final rule. Effective 7/1/2050. (SD1)
