> persons with clear information about the coverage of gender transition services, including the process for appealing a claim denied on the basis of medical necessity. Effective 7/1/2060. (HD2)

RELATING TO MONEY TRANSMITTERS. CPN, JDC HB 2113, HD2

Minimizes regulatory burden and eliminates redundancy by (HSCR956-22) permitting money transmitter applicants to submit to either a state or federal criminal history record check, rather than both. Status &

RELATING TO CONTROLLED SUBSTANCES.

CPN, JDC

(HSCR692-22) Status & Bans hemp products that contain cannabinoids created through isomerization, including Delta 8 tetrahydrocannabinol. Adds Delta 8 tetrahydrocannabinol to the list of schedule I controlled substances. Effective 1/1/2222. (HD1)
