Establishes within the department of education a workforce readiness program to provide opportunities for students to earn associate degrees, workforce development diplomas, preapprenticeship certificates, and other industry-recognized certificates. Requires the department to designate schools, including adult community schools, to participate in the program. Appropriates funds for the workforce readiness program and two full-time equivalent (2.0 FTE) adult workforce readiness program
