HB 1717 (HSCR33-22) Status	RELATING TO AGRICULTURE. Appropriates funds to the University of Hawaii to establish a foreign agriculture small equipment pilot program. Requires a report to the Legislature.	AGR, HET, FIN
HB 1844 (HSCR98-22) Status	RELATING TO THE UNIVERSITY OF HAWAII. Appropriates funds to the University of Hawaii for the College of Tropical Agriculture and Human Resources to establish one full-time agriculture education coordinator position.	AGR, HET, FIN

<u>HB 2305</u> (HSCR102-22) <u>Status</u>	RELATING TO THE UNIVERSITY OF HAWAII. Appropriates funds to the University of Hawaii for the College of Tropical Agriculture and Human Resources to study diseases affecting the production of ornamental red ginger on Oahu and the neighbor islands. HB 2302, HD1 (HSCR143-22) Status	RELATING TO THE UNIVERSITY OF HAWAII SEA GRANT COLLEGE PROGRAM. Appropriates moneys for the continued operation and disaster preparedness outreach efforts of the University of Hawaii sea grant college program. Effective 7/1/2050. (HD1)	PDP, HET, FIN
HB 2118, HD1 (HSCR202-22) Status	RELATING TO CYBERSECURITY. Codifies the existing Hawaii state cybersecurity program, administered by the office of homeland security in partnership with specified entities, to oversee cybersecurity and cyber resiliency matters. Eliminates the state cybersecurity, economic, education, and infrastructure security coordinator position. Effective 7/1/3000. (HD1)	CMV, HET, FIN
HB 426, HD1 (HSCR205-22) Status	RELATING TO TUITION WAIVERS. Requires UH and the community colleges under certain circumstances to waive tuition for dependent children of service-connected one hundred per cent disability veterans, active or reserve members of the armed forces who were killed in action, and purple heart medal recipients awarded in 2001 or later. Effective 7/1/3000. (HD1)	CMV, HET, FIN
HB 2054, HD1 (HSCR179-22) Status	RELATING TO ENERGY. Authorizes the Hawaii Technology Development Corporation to temporarily re-establish the Hawaii Office of Naval Research Grant Program to provide fifty per cent matching grants to Hawaii awardees of alternative energy research grants from the United States Office of Naval Research. Effective 7/1/2100. (HD1)	EEP, HET, FIN
