RELATING TO A BEHAVIORAL HEALTH LONG-TERM CARE **SB 2737** HMS/HTH, WAM FACILITY. Status & Authorizes the issuance of general obligation bonds to develop Testimony a long-term care facility at the Guensberg building on the Hawaii state hospital campus. **SB 2634** RELATING TO HEALTH. Establishes the fetal alcohol spectrum disorders special fund, to be administered by the Department of Human Services, and which shall consist of federal funds and interest earned on those funds. RELATING TO THE INDIVIDUALS WITH DISABILITIES **SB 2748** HTH/HMS. EDUCATION ACT. JDC/WAM Status & Requires the Department of Health to submit a request, as **Testimony** allowed by federal code, to the United States Department of Education to allow parents of children with a disability to continue receiving early intervention services after the child turns three years of age and until the child enters kindergarten.
