## RELATING TO PERSONS WITH DISABILITIES.

Establishes employment first as a state policy with respect to persons with disabilities. Requires state and county agencies to implement this policy in hiring and all programs and services administered or funded by the State or counties. Requires DHS to apply employment first principles to medicaid home- and community-based services waiver program personnel. Effective 12/25/2040. (HD2)
