RELATING TO NATIVE HAWAIIAN AFFAIRS. **SB 3357** HWN, WAM Requires certain departments and agencies to provide grants to Status & tax-exempt non-profit organizations that have experience and Testimony expertise in supporting and advancing Native Hawaiian communities. RELATING TO HAWAIIAN HOME LANDS. **SB 3247** HWN, WAM Requires the Department of Hawaiian Home Lands to build Status & apartments to address the housing needs of native Hawaiians Testimony on the waitlist. **SB 879** RELATING TO COUNTIES. HWN, JDC Gives counties jurisdiction over the infrastructure of the Status & Department of Hawaiian Home Lands housing developments in Testimony their boundaries under specific conditions. Requires counties, under specific conditions, to commence maintenance on that certain infrastructure within sixty days. **SB 3359** RELATING TO THE DEPARTMENT OF HAWAIIAN HOME HWN, WAM LANDS. Status & Establishes the Hawaiian home lands special fund. Testimony Appropriates funds into and out of the special fund for DHHL to

> enable beneficiaries of the Hawaiian home lands trust to acquire a residence and to enable the department to fulfill its fiduciary

duties to beneficiaries.
