Requires the Board of Education to hold not less than six community forums annually, with at least one forum in each county. SB 2393, SD1  (SSCR2168)  Status & Testimony	RELATING TO THE UNIFORM RECOGNITION AND ENFORCEMENT OF CANADIAN DOMESTIC-VIOLENCE PROTECTION ORDERS ACT. Enacts the Uniform Recognition and Enforcement of Canadian Domestic-Violence Protection Orders Act. Effective 1/1/2023. (SD1)	PSM, JDC
SB 2423 (SSCR2102) Status & Testimony	RELATING TO THE ELECTRONIC PRESCRIPTION ACCOUNTABILITY SYSTEM. Updates chapter 329, Hawaii Revised Statutes, to clarify who may access information stored in the electronic prescription accountability system.	CPN, JDC

**SB 2125** 

RELATING TO THE RESIDENTIAL LANDLORD-TENANT CPN, JDC SB 2494, SD1 (SSCR2232) Prohibits landlords from recovering possession of a dwelling unit from tenants if habitability of the dwelling unit is significantly Status & Testimony impaired. Sets a tenant's liability for rent if habitability of the dwelling unit is significantly impaired. Provides remedies for retaliatory evictions. (SD1) SB 2764, SD1 RELATING TO SPECIAL MANAGEMENT AREAS. WTL, JDC Expands exclusions from the definition of "development" as it (SSCR2206) applies to special management areas to reduce the need for special management area permits for certain activities. Takes Status & effect 7/1/2050. (SD1) Testimony RELATING TO THE BOARD OF EDUCATION. EDU, JDC SB 2824, SD1 Amends the minimum qualifications for board of education (SSCR2064) members. Effective 07/01/2050. (SD1) Status & **Testimony** SB 3140, SD1 RELATING TO THE UNIFORM CONTROLLED SUBSTANCES PSM, JDC ACT MANDATORY REPORTING. (SSCR2172) Requires the holder of a controlled substances registration to immediately verbally report the theft, embezzlement, fraud, or Status & Testimony diversion of a controlled substance in the holder's inventory. Requires the submission of a written report to the administrator of the Narcotics Enforcement Division that provides all information related to the theft, embezzlement, fraud, or diversion of controlled substances in the holder's inventory, including but not limited to, records, reports, and any image, film, video, or other electronic medium. Establishes a misdemeanor penalty for a person who prevents another from reporting, or who knowingly fails to provide information as required. (SD1) SB 3141, SD1 RELATING TO THE UNIFORM CONTROLLED SUBSTANCES PSM, JDC (SSCR2173) Updates the Uniform Controlled Substances Act, chapter 329, Status & Hawaii Revised Statutes, to make it consistent with Testimony amendments in the federal controlled substances law as required by section 329-11, Hawaii Revised Statutes. (SD1)
