SB 2017 Status & Testimony	RELATING TO EMERGENCY MEDICAL SERVICES. Repeals section 453-34(d), HRS, which limits licensure as an emergency medical technician 1 to individuals whose practice is performed in a county with a population of 500,000 or greater.	PSM/HTH, CPN
SB 2026 Status & Testimony	RELATING TO THE EMERGENCY MEDICAL SERVICES PERSONNEL LICENSURE INTERSTATE COMPACT. Enters Hawaii into the Emergency Medical Services Personnel Licensure Interstate Compact to allow EMS personnel from other states to practice in Hawaii during a declared emergency.	PSM/HTH, CPN/JDC
