Prohibits members of the Testimony Hawaii Workforce Development Board and local workforce development boards from engaging in any activity determined by the Governor to constitute a conflict of interest. Effective 12/25//2040. (SD1) RELATING TO THE PHOTO RED LIGHT IMAGING HB 2336, HD2, SD1 TRS, JDC/WAM DETECTOR SYSTEMS PROGRAM. (SSCR3432) Clarifies certain provisions in chapter 291J, Hawaii Revised Statutes, to better reflect the legislative intent of the photo red Status & light imaging detector systems program. Establishes minimum Testimony display times for yellow lights on traffic-control signals. Amends Act 30. Session Laws of Hawaii 2020, as amended, to account for the current timetable of the photo red light imaging detector systems program. Effective 7/1/2050.
