Authorizes the State to transfer ownership of roads in favor of counties by quitclaim if requested by the county.	GVO/WTL, JDC/WAM
SB 2725 Status & Testimony	RELATING TO SPECIAL IMPROVEMENT DISTRICTS. Expands the purpose and rationale for which counties may create special improvement districts to include environmental research, restoration, and maintenance; natural resource management; and natural hazard mitigation to improve environmental conditions and provide community benefits.	WTL/GVO, JDC/WAM
Status & Testimony	RELATING TO HISTORIC PRESERVATION REVIEWS. Transfers authority for certain reviews of projects in conjunction with section 6E-42, Hawaii Revised Statutes, from the Department of Land and Natural Resources to the Counties. Provides financial assistance to the Counties to hire qualified staff to conduct the reviews.	WTL/GVO, WAM
