RELATING TO FAIR HOUSING REASONABLE HMS, JDC SB 2002, SD1

ACCOMMODATIONS. (SSCR2336)

Defines "assistance animal" in the context of Hawaii law prohibiting discrimination in real property transactions. Codifies Status & the administrative process in verifying that a person requesting a Testimony

reasonable accommodation that include the use of an assistance animal has a disability and the assistance animal is needed to alleviate one or more symptoms of the person's disability. Specifies that possession of a vest or other

distinguishing animal garment, tag, or registration document commonly purchased online and purporting to identify an animal as a service animal or assistance animal does not constitute valid verification of a disability-related need for an assistance

animal. (SD1)

SB 2008 RELATING TO HIGHWAYS. PSM/TRS, JDC

Repeals the 3-year limit on the exemption of the State and (SSCR2578) counties from the requirement to maintain or improve any

condemned roads. Abolishes joint and several liability of the Status &

State and counties for any condemned roads. Testimony

HTH, JDC SB 2034, SD1 Requires assessment of patients who are subject to emergency (SSCR2308) hospitalization, diagnosed with a mental illness or severe substance use disorder, and found to be lacking decisional Status & Testimony capacity to determine if a surrogate or guardian needs to be appointed to make appropriate health care decisions for the patient. Authorizes certain health care providers to make determinations on the presence of mental illness, substance abuse disorder, and decisional capacity of the patient. Effective 1/1/2050. (SD1) SB 2065, SD1 RELATING TO FISHING. AEN/WTL. JDC Prohibits the possession or use of unmanned aerial vehicles in (SSCR2389) state waters for purposes of fishing. (SD1) Status & Testimony SB 2072, SD1 RELATING TO COURT-APPOINTED ATTORNEYS. HMS, JDC Requires the court to appoint counsel to indigent parents upon (SSCR2410) the filing of a petition for custody or family supervision and make every effort to do so at the first hearing attended by the parents. Status & **Testimony** (SD1) RELATING TO THE ROOM CONFINEMENT OF MINORS. **SB 2115** PSM, JDC Establishes conditions and time limits for placing a minor in (SSCR2165) room confinement at a detention or shelter facility. Effective upon approval. Status & **Testimony** RELATING TO TRAFFIC VIOLATIONS. TRS, JDC **SB 2118** Requires the driver of a moped to be in immediate possession of (SSCR2363) a valid driver's license or instruction permit at all times. Status & **Testimony SB 2126** RELATING TO TRANSPORTATION. TRS, JDC Increases the minimum and potential maximum fine for violating (SSCR2398) certain provisions relating to the installation of a noisy muffler. Status & **Testimony SB 2137, SD1** RELATING TO TRANSITIONAL HOUSING. GVO/HTH, JDC Requires the Department of Health and pertinent county (SSCR2652) agencies to work together to resolve problems and complaints regarding clean and sober homes. Requires the Department of Status & Health to educate the public on certain matters related to clean **Testimony** and sober homes. Takes effect 6/30/2022. (SD1) RELATING TO STATE EMPLOYEES. LCA, JDC **SB 2138, SD1** Subjects interns who work for the State to the provisions of (SSCR2457) chapter 84, Hawaii Revised Statutes, otherwise known as the State Ethics Code, by defining and including the term "intern" in Status & the definition of employees, who are subject to the provisions of Testimony the Code. (SD1)
