Hurricane Hilda Update

Tropical Storm Hilda continues to weaken. As of 5am Wednesday, August 12, National Weather Service update, Hilda was approximately 255 miles SE of Hilo with sustained winds at about 45 mph moving NW at 5 mph. At the 8am intermediate update, Hilda was nearly stationary, moving at just 1 mph. At this time, the tropical storm watch, high surf warning, and flash flood watch all remain in effect.

The likelihood of tropical storm force winds has reduced to less than 8%, and the forecast is for winds in the 20-30 mph range with higher gusts on the higher elevations. Hilda is forecast to become a tropical depression by Thursday and dissipate by early Friday. The center point of closest approach is estimated at 4pm Thursday afternoon.

Surf is being reported in the 8-12 foot range in some areas and the high surf warning is in effect thru Thursday. All ports remain open and the Captain of the Ports indicated that they do not anticipate closing any of the harbors to commercial activity as they had indicated yesterday.

The most significant threat with this system remains the anticipated heavy rains. Rain is still being forecast in the 6-12 inch range with local showers to 18 inches possible on east and southeast facing slopes. The flash flood watch remains in effect until Saturday morning.

The public is allowed to attend but not speak at the hearings unless a party involved asks for a closed meeting. PUC is expected to make a decision by June.
