Department of Human Services Announces Application Period for Preschool Open Doors Program

The Department of Human Services (DHS) will be accepting applications for its Preschool Open Doors (POD) program between March 1 and April 30, 2015. Applications received during this period will be considered for preschool participation between July 1, 2015 and June 30, 2016.

POD is a DHS child care subsidy program that provides statewide services to eligible low- and moderate-income families sending their children to a licensed preschool, prior to kindergarten entry. The goal of POD is to promote school readiness and to provide children with the opportunity to gain essential foundational skills they need to be successful in life.

Families are reminded that a child must be five years old on or before July 31 to enter kindergarten. Families with children born between August 1, 2010 and July 31, 2011 are encouraged to apply for the POD program. Underserved or at-risk children will receive priority consideration for the 2015-2016 POD year.

LEGISLATION

The following bills may be of interest to you and your family and are currently alive (as of the date of this newsletter's printing) and are being prepared for crossover to their respective chambers. For up-to-date information on these and other bills visit: http://www.capitol.hawaii.gov/.

HB329 - RELATING TO TAX CREDITS.

Amends the refundable food/excise tax credit. Ties the credit to increases in the Consumer Price Index.

HB448, HD1 - RELATING TO DOMESTIC VIOLENCE.

Requires the Department of Health (DOH) to conduct reviews of domestic violence fatalities, near-deaths, and suicides. Authorizes DOH to enter into memoranda of understanding to obtain information relating to near-deaths resulting from intimate partner violence. (HB448, HD1)

HB445, HD1 - RELATING TO TRANSIT-ORIENTED DEVELOPMENT.

Authorizes the Hawaii Housing Finance and Development Corporation to offer loan guarantees to encourage affordable housing as part of transit-oriented development. (HB445, HD1)

HB849 - RELATING TO AGRICULTURE.

Amends Hawaii's Right to Farm Act to ensure that counties cannot t

enact laws, ordinances, or resolutions to limit the rights of farmers and ranchers to engage in agricultural practices.

HB1092 - RELATING TO TAXATION.

Excludes income received from deferred compensation retirement plans from the state income tax for taxpayers who meet certain income requirements.

HB1153 - RELATING TO VETERANS.

Exempts qualifying totally and permanently disabled veterans from paying the State motor vehicle registration fee. Requires the office of veteran's services to report the number of qualifying veterans to the legislature and department of taxation. Applies to motor vehicle registration occurring on or after September 1, 2015.

HB1160 - RELATING TO RELIGIOUS RIGHTS.

Prohibits the State or any county from burdening any person's right to exercise religion absent that burden being the least restrictive means of furthering a compelling governmental interest.

HB1248 - RELATING TO SEXUAL ASSAULT.

Mandates a Family Court to terminate the parental rights to any child of a natural parent if the natural parent is convicted of rape or sexual assault and that rape or sexual assault resulted in the conception of the child.
