#### STAY AT HOME EXTENDED

Governor David Ige extended the stay at home and work from home order until at least May 31 but is working on a statewide reopening plan that will be based on facts, science, and guidance from healthcare advisors.

Key metrics under consideration include a decrease in cases, comprehensive testing and surveillance capacity, and a well-developed contact tracing system. As a state, a phased approached to reopening will be implemented and the intent is for measures to be relaxed before the end of May.

#### PHASED REOPENING

As of May 1, Mayor Michael Victorino began a phased reopening. The first phase includes opening selected parks, beach parks, and golf courses. The parks and beach parks selected were based on feedback from the community and will be open for EXERCISE ONLY. A few of the parks and beaches opened in our area include Keopuolani Regional Park, Waiehu Beach Park, and the Waiehu Golf Course. The reopening also includes guidelines for wearing masks in public and allows for vehicle safety checks to resume.

Effective May 7, Gov. Ige has allowed the **reopening of non-food agriculture operations**, **car washes**, **auto dealerships**, **pet grooming services**, **health care entities for elective surgeries and non-emergency services**, **nonprofit organizations**, **along with automobile and appliance repair shops**. The activities must follow social distancing, sanitation and safety guidelines. **Reopenings also vary by County**. More information will be announced as it is available. #### **EXTENSION OF IDs AND SAFETY CHECKS**

The State Department of Transportation (HDOT) announced continuing waivers and extensions.

**Driver's licenses, instruction permits, and State Identification cards** that expire between March 15 and May 31, 2020, are granted a 90-day waiver starting on May 31. The extension provides the public time to obtain or renew credentials once face-to-face government services are reopened.

Commercial Driver's License (CDL) holders with a CDL that expired between March 16 through May 31, 2020, are allowed an extension of up to 90 days but the 90 days cannot extend past June 30, 2020. The Federal Motor Carrier Safety Administration (FMCSA) has set June 30 as the last date that an extension may be granted.

**Safety check certificates and stickers** expiring on or before May 31 will remain valid until August 31. All other safety checks that expire in 2020 will be valid for an additional three months after the 2020 expiration date.

## Unemployment insurance a top priority

The State Department of Labor and Industrial Relations (DLIR) is working to clear the back-log of unemployment insurance claims and is continually working to upgrade its system to help the process more claims. As of May 5, about 234,000 jobless claims statewide have been filed and a total of 88,818 claims have been successfully processed and paid with about 37,000 claims being denied.

In response to the high demand, two new call centers have been established at the Hawai'i State Convention Center and Hawai'i State Library, 76 DLIR employees have been transferred to the Unemployment Insurance Division, and 18 employees have been transferred to help with complicated claims processing. Over 100 legislative staffers have also been volunteering to process claims.

I understand the deep frustration experienced by the community. Processing the back-log is my top priority. You have my commitment that I will personally continue to pressure DLIR and the governor to move faster and allocate the needed resources to process all claims.

#### ASSISTANCE FOR SELF-EMPLOYED AND INDEPENDENT CONTRACTORS

Self-employed individuals and independent contractors may now apply for Pandemic Unemployment Assistance (PUA) through a new system launched by the state. Up to \$600 per week is available through the federal CARES Act and is intended to help those typically not eligible for unemployment benefits. According to DLIR, as of April 27, pre-applications are being accepted. By May 15, additional features will be added to process applications, and additional information will be sent regarding the next steps.

If you applied through the regular unemployment system and were denied, please re-apply through the PUA system. To ensure that applications are processed in a timely manner, the information you submit, including income, will be validated against Hawai'i tax records. If the data does not match, it will delay processing of the application.

The caller may receive basic health advice or information and, with parental consent, the student may be scheduled for a telehealth visit with an HK nurse practitioner. #### Capital Improvement Project funds released

Governor David Ige announced the release of funding for the following projects appropriated by the Legislature in 2019.

#### Rehabilitation of old UHMC Dorms

\$5 million was released to rehabilitate the old University of Maui college dorms into a homeless housing and assistance center in coordination with the County of Maui.

#### Central Maui TOD Study

\$500,000 was released to fund a transit-oriented development corridor master plan by the County of Maui to



connect Wailuku and Kahului along Kaahumanu Ave. The plan will identify



redevelopment opportunities, including transportation improvements, to capitalize on the potential for affordable housing. jobs, public services, and other amenities to create walkable communities.



## The more you know... Community Updates

### Water shortage for Wailuku, Kahului, and Paia

The County of Maui Department of Water Supply declared a Stage 1 water shortage on April 27 for its domestic water system serving residents of Wailuku, Kahului, and Paia.

Due to a water pump failure in April, the department is requiring residents of Wailuku, Kahului, and Paia to cut back water usage by



at least 10 percent from May 3 until further notice.

"This recent failure reduced our water production by an additional 2 million gallons per day, which is

significant when combined with three other wells being out of service. With four pumps out of service, the department's capacity to deliver water is down by as much as 6 million gallons per day," Department of Water Supply Director Jeffrey Pearson said.

DPW is increasing production at other wells and at the Iao Water Treatment Plant to offset the loss of water from the four wells.

The Department is hoping to have two of the four wells back in service by the end of May.

## Maui Lani roundabout project

The County of Maui's construction on the Maui Lani roundabout project began in April at the intersection of Maui Lani Parkway and Kamehameha Avenue in Kahului.

Goodfellow Brothers is the general contractor on the \$3.15 million Maui Lani roundabout project, which *is expected to take approximately eight months to complete*.

Work hours are from 7 a.m. to 3:30 p.m., Monday through Friday, except for holidays. The project will be constructed in four phases.

The project's first phase will include utility relocation and trenching work. All approaches will be restricted to one lane in each direction, and the intersection will continue to operate as a four-way stop.

The project's scope includes removal of obstructions, performance of road pavement work, construction of curb ramps and sidewalks, adjustment of manholes, installation of irrigation and water valves, creation of a storm drain culvert, replacement of street signs and other improvements.
