

## **Marumoto Activities**

Marumoto is slated to be Secretary of Women in Government – As an officer on WIG, Rep. Marumoto will attend the November meeting on Health Disparities in Washington D.C.

Rep. Marumoto is helping an individual who wants to purchase and donate a facility to house foster children who are "aging-out". Generally, the program only covers children 18 and younger. The representative can help by guiding individuals through the red tape of rules/regulations, departments and programs. She was also happy to support the Hawaii Fire Fighters Association fundraising concert.

<u>Signposts</u> – The "First Lady of Limu" passed away. The UH publication Malamalama recently featured Isabella Abbott, 90, world-renowned algae taxonomist and ethnobotany professor emerita. She was the first Native Hawaiian woman (her father was Chinese) to receive a PhD in science and the first woman faculty member of Stanford University's biological sciences department where she taught for 30 years. Abbott discovered 200 types of algae and an entire genus is named *Abbottella*.

#### Non-Profits, Beware of Tax Changes

Marumoto voted NO on this measure because she felt it could be a precursor to taxing certain non-profits.

On June 1, 2010, Governor Lingle signed House Bill 2595 HD1 SD2 CD1 into law as Act 155, SLH 2010. Known as the "GET Protection Act", this Act *denies* certain general excise tax benefits (including exemption from the tax) to certain non-profits (churches exempted) that fail to comply with administrative procedures. This Act poses new paperwork problems, especially for small organizations.

The simplest way to comply with Act 155, SLH 2010 is to meet the following administrative requirements:

- Filing for and obtaining a general excise tax license (available on Form BB-1, State of Hawaii Basic Business Application; and
- Filing the annual general excise tax reconciliation tax return on Form G-49, Annual Return & Reconciliation of General Excise/Use Tax Return, within 12 months from the due date of the return.

If you are already engaged in a business, you already do this. Where many nonprofits are getting hung up is when they don't raise a great deal of money, are too small, have a small budget, feel they have a small membership, etc... The scope of the legislation does *not* take this into consideration.
