"NO" VOTES AT THE CAPITOL

House Bill No. 1242 – Relating to Renewable Energy – This bill would impose renewable energy standards on the state's gas utility companies, which import less than 2% of fossil fuels into the state. While the technology exists to create renewable gas, it has not been fully developed to meet the state's demand for gas.

House Bill No. 1851 – Relating to Grid-Interactive Water Heater Systems - Would prohibit the issuance of building permits for new multi-unit dwellings that do not include grid-interactive water heater systems. This government mandate would increase the cost of housing.

House Bill No. 1930 – Relating to Taxation – This bill initially increased the rental motor vehicle surcharge tax to \$8 per day. The current rate is \$5 per day.

House Bill No. 1944 – Relating to the Transient Accommodations Tax – This bill would add another layer of bureaucracy to government, allocating \$5 million to the Hawaii Tourism Authority (HTA). HTA would prioritize projects, and then the funding would be spent by the Department of Land and Natural Resources.

House Bill No. 1946 – Relating to the Transient Accommodations Tax – This bill would place caps on the amount each county receives from the tax instead of receiving a specified sum. It would also require the counties to request reimbursement from the state within 90 days of spending county funds. This bill may have far reaching implications in county budgets, and could, in a worst-case scenario, lead to increased property taxes.

House Bill No. 2227 – Relating to Energy Efficiency – Would impose state energy standards on air purifiers and home spas. I voted no on this bill because state regulatory requirements which exceed U.S. EPA standards will likely increase the cost of these products for the consumer.

House Bill No. 2475 – Relating to Cargo Carriers – Would allow the Department of Transportation to provide subsidies to cargo carriers serving Maui County. This bill, if passed, would give an unfair advantage to a single cargo carrier.
