In accordance with Act 132 of 2018, the Department of Health was authorized to establish a cesspool conversion working group. The purpose of this working group is to develop a long-range, comprehensive plan for cesspool conversion statewide for all cesspools by 2050.

## Happening At Hale Mahaolu Ewalu

Hale Mahaolu Ewalu is currently under construction in the Kulamalu Town Center Subdivision in Pukalani. This is the second senior rental housing campus in the Upcountry area.

Phase I will include 38 affordable rental units, a manager's unit, a Senior Center, a laundromat, beauty salon, administrative offices and a maintenance shop. This phase is planned to be completed in the next few months.

The County has already completed its application and lottery method and is currently in the process of screening applicants for qualification under the voucher program. The applicants will be further screened by Hale Mahaolu to ensure compliance with the federal tax credit program.

Phase II will include another 22 affordable rental units and construction will commence in 2019. For more information, please check their website at www.halemahaolu.org.
